INTUIT LINK: It's time once again to start gathering your tax documents. New this year is Intuit Link which is going to be my new document sharing portal. We will continue to use Smart Vault this year, but it will begin to be phased out by year end. I will be sending you a link this week to get Intuit Link set up. One big benefit of Intuit Link is it provides you a list of the exact documents you had the year before so it is easy to know what to look for. I think you will enjoy using this new portal.

SMART VAULT: If you wish to use the Smart Vault portal again this year, here is the link to access this. You should have your own login for this.
